

GENERAL ORDINANCE NO. 1150

**A GENERAL ORDINANCE TO AMEND GENERAL ORDINANCE NO. 976,
AN ORDINANCE AMENDING GENERAL ORDINANCE NO. 442 AS
AMENDED BY GENERAL ORDINANCE 665
TO AMEND THE FOLLOWING SECTIONS CONTAINED IN
ARTICLE 20: 15-148 SCHEDULE 5, STOPPING, STANDING OR PARKING
PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS and
ARTICLE 20: 15-149 SCHEDULE 6, PARKING TIME LIMITED ON CERTAIN
STREETS**

**BE IT ORDAINED by the Common Council of the City of
Kendallville, Indiana**

Section 1. That Article 20 of General Ordinance No. 442 of the City of Kendallville, Indiana, as amended by General Ordinance No. 665, being a traffic ordinance regulating traffic, which ordinance provides for penalties thereof, is hereby amended by amending and changing the schedules contained in Article 20, including:

Schedule 5, Stopping, Standing or Parking prohibited during certain hours on certain streets, and the same is hereby amended by removing the following location as follows:

1. The north side of Rush Street from Orchard Street to State Street during the hours of 3:00 a.m. to 6:00 a.m., except Sundays and holidays.

Schedule 6, Parking time limited on certain streets, and the same is hereby amended by removing the following:

1. The north side of Rush Street between Main Street and State Street
2 hour parking except Sundays and holidays from 9 a.m. to 6 p.m.
2. The north side of Rush Street between Orchard Street and Alley 24W
2 hour parking except Sundays and holidays from 9 a.m. to 6 p.m.

Schedule 6, Parking time limited on certain streets, and the same is hereby amended to include the following:

1. The north side of Rush Street from Main Street to and including the first designated parking space east of Alley 6E.
2 hour parking except Sundays and holidays from 9 a.m. to 6 p.m.

Section 2. All references to alley locations (e.g. Alley 6E) are based on the official City of Kendallville Alley Map adopted as part of General Ordinance 976.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor and legal publication.
