

**GENERAL ORDINANCE NO. 1152**

**AN ORDINANCE AMENDING GENERAL ORDINANCE NO. #851  
AN ORDINANCE TO REGULATE SEWER USES**

**Section 1. BE IT ORDAINED by the Common Council of the City of Kendallville, Indiana, that the said City now and hereby amends the SEWER USE REGULATIONS to change and/or include the following in Chapter 16, ARTICLE III -**

**DIVISION 1. GENERALLY**

**Sec. 16-169. Definitions.**

*Lateral Line* - the private sanitary sewer from any structure or dwelling to and inclusive of the "tap" belonging to the private owner(s) connecting to the public sanitary sewer.

*Private Sanitary Sewer* - a sewer which is NOT owned by a public authority

*Private Storm Sewer* - means a sewer which is NOT owned by a public authority.

*Public Sanitary Sewer* - a sewer which is owned and controlled by the public authority and consists of the following increments:

1. Main - a sewer whose primary purpose is to collect wastewaters from lateral line(s)
2. Trunk - a sewer whose primary purpose is to collect and transport wastewater from mains
3. Interceptor - a sewer whose primary purpose is to collect wastewater from "trunks" and transports the wastewater to the P.O.T.W.

*Sewer* - means a pipe, drain or conveyance system used to carry off wastewater and storm water.

*Stormwater* - means any flow occurring during or following any form of natural precipitation and resulting therefrom, including snowmelt and ground waters.

*Tap* - the private sewer, sanitary and/or storm, connection on and attached to the City's sewer, sanitary and/or storm, system which includes the area to the first joint on each side of the lateral line connection into the City's system and is the responsibility of the private owner(s) for any and all costs incurred for maintenance, proper operation, repairs and construction to ensure proper operation.

**SECTION 2. That this ordinance shall be in full force and effect from and after it's passage and approval by the Mayor.**
