

GENERAL ORDINANCE NO. 1155

An Ordinance Vacating a Public Way or Place in the City of Kendallville, Noble County, Indiana, pursuant to I.C. 36-7-3-12.

BE IT ORDAINED by the Common Council of the City of Kendallville, Indiana:

Section 1. That subject to any utility easements, that the following ALLEY
(STREET OR ALLEY)
hereinafter described is now vacated, to wit:

All that portion of the 12 foot wide east-west alley located between Lot numbers 44 and 45 to the north and Lot numbers 43 and 46 to the south as found in the Plat of Daniel’s Enlarged Addition to the City of Kendallville and as recorded in Record Book 17 Page 495 in the Office of the Noble County Recorder.

Section 2. It is further ordained that this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor and the Common Council of the City of Kendallville, and upon said approval title thereto shall revert to the adjoining landowners of said twelve (12) foot vacated
(WIDTH)
alley
(STREET OR ALLEY).

The North 6 feet shall revert to the adjoining owner(s) of lot # 44 of Daniels Enlarged Addition,
DIRECTION FOOTAGE
or the attached legal description referred to as Exhibit “_”, the owner(s) being Michael S. Terry, and

The South 6 feet shall revert to the adjoining owner(s) of lot # 43 of Daniels Enlarged Addition,
DIRECTION FOOTAGE
or the attached legal description referred to as Exhibit “_”, the owner(s) being Michel S. Terry, and
OWNER(S) NAME(S)

The North 6 feet shall revert to the adjoining owner(s) of lot # 45 of Daniels Enlarged Addition,
DIRECTION FOOTAGE
or the attached legal description referred to as Exhibit “_”, the owner(s) being Benjamin Petrow, and
OWNER(S) NAME(S)

The South 6 feet shall revert to the adjoining owner(s) of lot # 46 of Daniels Enlarged Addition,
DIRECTION FOOTAGE
or the attached legal description referred to as Exhibit “_”, the owner(s) being Benjamin Petrow, and
OWNER(S) NAME(S)
